Annoor Journal of Scientific Research (AJSR) is the official publication of Annoor Dental College & Hospital, Muvattupuzha. AJSR publishes scientific papers on well designed and controlled original research involving maxillofacial and allied sciences. Papers may also include reports on unusual and interesting case presentations and invited review papers on significant topics. AJSR expects the highest ethical standards from their authors, reviewers and editors when conducting research, submitting papers and throughout the peer-review process.

Abstracting and Indexing Information - will be applicable only after the first three issues are released.

Journal Ethics

AJSR is committed to meeting and upholding standards of ethical behavior at all stages of the publication process. We follow closely the industry associations, such as the Committee on Publication Ethics (COPE), International Committee of Medical Journal Editors (ICMJE) that set standards and provide guidelines for best practices in order to meet these requirements. http://www.icmje.org/recommendations/browse/publishing-and-editorial-issues.html)

Peer Review

AJSR employs a double-blind review process, in which the author identities are concealed from the reviewers, and vice versa, throughout the review process.

Conflicts of interest

At the point of submission, policy requires that each author reveal any financial interests or connections, be it direct or indirect, or other situations that might raise the question of bias in the work reported or the conclusions, implications, or opinions stated - including pertinent commercial or other sources of funding for the individual author(s) or for the associated department(s) or organization(s), personal relationships, or direct academic competition. If present it should be clearly mentioned.

If the manuscript is accepted, Conflict of Interest information will be communicated in a published statement.

Patient consent forms

The protection of a patient's right to privacy is essential. Please collect and keep copies of patients' consent forms on which patients or other subjects of your experiments clearly grant permission for the publication of photographs or other material that might identify them directly or indirectly. If the consent form for your research did not specifically include this, please obtain it or remove the identifying material.

A line stating that such consent had been obtained must be included in the 'Methods' section of your article. If necessary the Editors may request a copy of any consent forms.

Ethics committee approval

All articles dealing with original human or animal data must include a statement on ethics approval at the beginning of the Methodology section. This paragraph must contain the following information-

- 1. the name and address of the ethics committee responsible;
- 2. the protocol number that was attributed by this ethics committee:
- $3.\ \ and the \ date \ of approval \ by \ the \ ethics \ committee.$

Plagiarism

AJSR evaluates submissions on the understanding that they are the original work of the author(s). Re-use of text, data, figures, or images without appropriate acknowledgment or permission from the copyright owner is considered plagiarism, as is the paraphrasing of text, concepts, and ideas.

Follows the current UGC guidelines, also keeping in mind the regulations released on 23rd July 2018.

Retraction policy

Instructions to authors

The manuscripts will be reviewed for possible publication with the understanding that they are being submitted to this journal at a time and have not been published, simultaneously submitted, or already accepted for publication elsewhere. When the article has been submitted to AJSR for consideration for publication, it implies that the authors have transferred the copyright to AJSR. The views/opinions of the authors are their own. The journal bears no responsibility what so ever. The decision regarding approval/rejection is solely by the editorial board of AJSR.

Types of Manuscripts and word limits

Original research articles: Randomised controlled trials, intervention studies, studies of screening and diagnostic test, outcome studies, cost effectiveness analyses, casecontrol series, and surveys with high response rate. Up to 2500 words excluding references and abstract.

Short Communication: Up to 1000 words excluding references and abstract and up to 8 references. A short communication contains only a short report of the case (only pertinent details) and a short discussion and references upto a maximum of 8. OR a short research that does not require further confirmation. Number of figures should be restricted to a maximum of 6.

Case reports: New / interesting / very rare cases can be reported. Cases with clinical significance or implications will be given priority, whereas, mere reporting of a rare case may not be considered. Up to 2000 words excluding references and abstract.

Review articles: Systemic critical assessments of literature and data sources. Up to 3500 words excluding references and abstract. Authors submitting review manuscripts should include a section describing the methods used for locating, selecting, extracting, and synthesizing data. These methods should also be summarized in the abstract

Sending the Manuscript to the Journal-

Articles should be submitted via email to annoorjournal@gmail.com

First Page File: Prepare the title page, covering letter, acknowledgement, etc., using a word processor program. All information which can reveal your identity should be here.

Article file: The main text of the article, beginning from Abstract (of no more than 150 words for case reports, brief reports and 250 words for original articles) till References (including tables) should be in this file. Do not include any information such as acknowledgement, your names in page headers, etc., in this file. Figures , tables, graphs should be appropriately labelled and added at the end of the article, i.e., after the references. If the clarity of the images are of not good quality the author will be intimated and they would have to be mailed separately.

Preparation of the Manuscript-

Use 1.5 spacing throughout. Number pages consecutively, beginning with the title page.

The language should be British English.

The font shall be preferably Times New Roman size 12

The article file should carry the full title of the manuscript and an abstract (of no more than 150 words for case reports, brief reports and 250 words for original articles). The abstract should be structured and state the Context (Background), Aims, Settings and Design, Methods and Material, Statistical analysis used, Results and Conclusions. Below the abstract the authors should provide 3 to 10 key words.

References should be numbered consecutively in the order in which they are first mentioned in the text (not in alphabetic order). Identify references in text, tables, and legends by Arabic numerals in superscript. The references should be in Vancouver style.

Conflict of interest and funding: please mention the details of the same.

Article publication charges: Free.

Final decisions pertaining to the content and publication process of the journal will be taken collectively by the Editor- in -Chief of AJSR, Principal, Vice-Principal and the Management of Annoor Dental College, Muvattupuzha.
