INSTITUTIONAL PUBLICATION GUIDELINES AND NORMS

All biomedical and health research conducted in the institution must be carried with integrity and high-quality standards. The quality of research is to be guided by the regulations and guidelines laid down in the institution as per the guidelines prescribed by National and international bodies. The research team should maintain highest standards to uphold the fundamental values of research.

All research work conducted within the institution must be published with a renowned database during a stipulated time period

Completed research irrespective of results must be published and shared on public databases like institute websites or other relevant platforms.

Researcher must ensure authenticity of research results before reproducing or publicizing information out of the Institution.

Researchers should follow guidelines of International Committee of Medical Journal Editors (ICMJE), Committee on Publication Ethics (COPE) on publication ethics, research integrity and authorship for the publication or presentation. The manuscripts should/must not be submitted to any predatory journals.

Publication should be in indexed journals/ renowned journals with high impact factor indexed journal citation reports (JCR) journals.

Plagiarism:

Plagiarism in any sort of matter is not entertained by the institution or any form of research misconduct is unethical.

Self-plagiarism, fabrication, falsification, manipulation of data or images, wrong interpretation and use of statistical tools, gift/ghost authorship etc. is not encouraged in the institution.

The research documents with acceptable level of plagiarism (<10%) or without identified misconduct shall be forwarded by Head/ institutional research committee chairperson for approval before publication/dissemination

Authorship credentials:

The researchers should follow the guidance of International Committee of Medical Journal Editors (ICMJE) on authorship

Ghost/gifted authorship are not permitted and contributions by all authors should be clearly identified, collaborations if any, may be declared preferably at the time of project initiation with the name and details of collaborators and must be intimated to the ethical committee/ research committee.

The primary author should be the person who has done most of the research work/ principal investigator related to the manuscript being submitted for publication. Research performed

as part of a mandatory requirement of a course/fellowship/training programme including student research should have the candidate as the primary author. All efforts must be made to provide the candidate with an opportunity to fulfil the second, third and fourth criteria of the ICMJE guidelines.

Role of all authors should be clearly identified/justified. Authorship should be duly given to all those who have substantially scientifically contributed to the research and can include permanent / temporary staff.

ICMJE Guidelines/ criteria for authorship:

Substantial contributions to the origin or design, data acquisition, analysis, or interpretation of data of the research

- Drafting/ revision of scientific content;
- Final approval of the manuscript to be published
- Agreement to be accountable for all aspects (accuracy or integrity) of the research work carried out

Before publication or dissemination, the corresponding author should submit the final draft along with details of authorship and plagiarism check report to the Head/ institutional research committee chairperson for approval and will be cross verified for any misconduct before giving approval (15 days)
